#### Liability/waiver:

The specific risks vary from one activity to another, but the risks range from: 1) minor injuries such as scratches, bruises, and sprains; to 2) major injuries such as eye injury or loss of sight; joint, bone or back injuries; heart attacks; or concussions; to 3) catastrophic injuries including paralysis and death.

**Indemnification and Hold Harmless**: I also agree to DEFEND, INDEMNIFY AND HOLD HARMLESS the District and the Foundation, and their respective administrators, directors, officers, employees, members, agents, or volunteers, from and against any and all claims, actions, suits, proceedings, costs, expenses, damages and liabilities, including attorneys' fees brought as a result of my involvement in the Hanna Powder Puff Football Game, and to reimburse them for any such expenses incurred.

**Severability**: The undersigned further expressly agrees that the foregoing waiver and assumption of risks agreement is intended to be as broad and inclusive as is permitted by the law of the Commonwealth of Pennsylvania and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

Acknowledgement of Understanding: I have read this waiver of liability, assumption of risk, and indemnity agreement, fully understand its terms, and understand that I am giving up substantial rights, including my right to sue. I acknowledge that I am signing the agreement freely and voluntarily, and intend by my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law.
